7. I understand that I am required to attend 100% of the SMIPA classes, except where there is a legitimate reason for non-attendance that is acceptable to AAPoly. I must provide evidence of legitimate reason such as a medical certificate for absences of two or more days.
8. I am responsible for all my health costs while I am in Australia. I must have adequate health insurance unless I am covered by Medicare. I will ensure that my health insurance will provide at least the level of coverage required for the purpose of my stay. Overseas Student Health Cover (OSHC) is acceptable health insurance if you are still on a student visa when you lodge your application for a Temporary Graduate visa (subclass 485). OSHC is not acceptable if you no longer hold a student visa (for example, if you are granted a bridging visa during the visa processing period or if you are granted a Temporary Graduate visa).
9. I am aware that successfully completing the Professional Year (PY) allows applicants to claim an additional 5 points towards Points Tested Skilled Migration visa categories. However, AAPoly has reminded me that the actual eligibility for these 5 points can be a complex area of visa policy which is dependent on several other factors including the Australian Study Requirement, the provision of a valid skills assessment, being in a nominated occupation and the amount of time that lapses between an applicant finishing their study and PY, and when they apply for permanent migration. AAPoly made me aware that enrolling in SMIPA does not automatically entitle me to 5 points for PY.

I certify that the information on this form and the supporting documentation are correct and complete. After taking into consideration all of the above reminders, I have made my informed decision to proceed with my enrolment in SMIPA at AAPoly.
